Studio Industria makes no other warranty and no actions or words of Studio Industria or its officers, employees or agents shall constitute a warranty.

WORKMANSHIP GUARANTEE

We guarantee all orders to be free of defects in workmanship. If any order does not match the generally accepted trade/industry standards, we will reprint the order when available.

INDEMNIFICATION

The customer represents that it has the legal right to produce all printed materials ordered from Studio Industria.
